ASX – OLI EG Opens First Oliver's Franchise Store

Oliver's Real Food Limited (the **Company**) is delighted to announce that we have today opened the first Oliver's Real Food franchise store in conjunction with EG Fuelco (Australia) Limited (**EG**).

As announced to the market on 7 October 2020, the Company entered into a Master Franchise Agreement with EG, appointing EG as its exclusive franchisee of Oliver's Real Food branded cafés in the petrol and convenience sector in Australia.

Just over two months after entering into that Master Franchise Agreement, EG have today opened the first of these franchised stores at 67 Orange Grove Road, Liverpool in Sydney's Western Suburbs, with two more Western Sydney locations already in the pipeline to open in 2021.

The new OLI-Burger will hit a "hot spot" with customers craving a delicious burger, but also wanting to eat more healthily, make a better choice for the environment, and protect animal rights.
