## 22 December 2022 ASX Announcement

## Oliver's Real Food Limited (ASX: OLI) Monthly Appendix 4C – November 2022

Further to ASX's request, pursuant to listing rules 18.7 and 18.8 that Oliver's Real Food Limited ("OLI" or the "Company") lodge a monthly report in the form of an Appendix 4C under listing rule 4.7B, commencing with an Appendix 4C for May 2021, the Company provides the Appendix 4C for the month of November 2022.

### **November trading commentary**

Oliver's continued its positive momentum in November, with the Company recording its third consecutive month of EBIT profit.

The Company further reduced its trade and other creditors, resulting in a negative Cash Flow from Operating activities of \$35k for the month.

Over the first 5 months of the FY23 financial year Working Capital has improved by \$1.7m.

Same store sales for December are currently tracking 16.80% ahead of last year.

## **Material business activities for November**

- Company-owned store sales \$1,931,166
- Like-for-like store comparison up 34% on 2021 sales, down 8% on November **2019**.
- Like-for-like store State performance compared with 2021: NSW up 31%, VIC up 60%, QLD down 8%.
- Like-for-like store State performance compared with <u>2019</u>: NSW down 3%, VIC down 24%, QLD down 7%.
- Oliver's Food to Go total sales were \$389k on which the Company earned \$36k in royalty.

## Payments to related parties (Listing Rule 4.7C.3)

Interest paid to related party entities on loans was \$45k for the month. Directors' Fees paid were \$7k.
