# Monthly and Quarterly Appendix 4C - December 2021

Further to ASX's request, pursuant to listing rules 18.7 and 18.8, that Oliver's Real Food Limited ("OLI" or the "Company") lodge a monthly and quarterly report in the form of an Appendix 4C under listing rule 4.7B, commencing with an Appendix 4C for December, the Company provides Appendix 4C for both the month and quarter ending 30 December 2021.

The Company's material business activities for December 2021 included:

- Company-store sales \$2,560,219, down 28.50% on <u>2019 sales.</u>
- State performance compared with <u>2019</u>: NSW down 23.57%, VIC down 39.20%, QLD down 7.15%.
- Oliver's Food to Go total sales were \$442,316 and 12 more EG service stations were added, bringing to 189 the total number of service station as of 31 December 2021.
- Settlement of the sale of two blocks of land in Aratula QLD nets close to \$300k.

The Company further reports that the expenditure in the December monthly 4C, to related parties reported at Item 6.1, is solely Directors' fees paid to Non-Executive Directors and these payment relate to the period November 2021.
