Oliver's Real Food Limited (ASX: OLI) Monthly Appendix 4C – August 2022

Further to ASX's request, pursuant to listing rules 18.7 and 18.8, that Oliver's Real Food Limited ("OLI" or the "Company") lodge a monthly report in the form of an Appendix 4C under listing rule 4.7B, commencing with an Appendix 4C for May 2021. The Company provides an Appendix 4C for the month ending 31 August 2022.

The Company's material business activities for August 2022 included:

- Company owned store sales \$1,721,808 up 696% on 2021 sales, but down 19% on <u>August 2019</u>.
- State performance compared with 2021: NSW up 1,473%, VIC up 372%, QLD up 45%.
- State performance compared with <u>2019</u>: NSW down 13%, VIC down 32%, QLD down 14%
- Oliver's Food to Go total sales were \$392,000.

During August, a one-off \$80k 'make good' payment was made on the final assignment of the Queensland kitchen lease and reported at item 1.8 of cash flows from operating activities. This expense was accrued in our FY2022 accounts.

The Company further reports that the expenditure in the August monthly 4C to related parties reported at Item 6.1 is solely Directors' fees paid to Non-Executive Directors.

Trading Update

- July and August sales were above forecast.
- Over the last 14 weeks excluding the school holiday peaks, we note that across the current 16 store network,
 - weekly transactions increased 12%,
 - o sales increased 18% and
 - o gross margins increased from 57% to 61%
- For the first two months of the 2023 financial year, our unaudited Earnings before Interest and Tax (EBIT) was a loss of \$49k. This compares with a loss of \$1.337m in the corresponding period for the 2022 financial year.

Answer: No, our FY23 forecast indicates cash flow will improve in the coming months, which assumes for improvement in revenue and further cost reduction measures

8.6.2

Answer: Yes, The Company is in continued discussions with its lenders and maintains their support. The current line of credit facility was increased in May by a further \$2m. The Company remains committed to raising equity and in currently considering all options, but the timing remains undecided whilst our shares are suspended.

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, assuming the continued support of lender and improved revenue, forecasted in the months ahead, occurs.
